

ABM Industries Announces Third Quarter Cash Dividend

NEW YORK - June 2, 2008 - The Board of Directors of ABM Industries Incorporated (NYSE: ABM) has declared a third quarter cash dividend of \$0.125 per common share payable on August 4, 2008 to stockholders of record on July 3, 2008. This will be ABM's 169th consecutive quarterly cash dividend, and is \$0.005 (4.2%) above the \$0.12 per share quarterly dividend rate declared and paid for the third quarter of 2007.
