

ABM Industries Continues Best-Ever Quarterly Dividend Rate

This will be ABM's 161st consecutive quarterly cash dividend, and is \$0.005 (4.8%) above the \$0.105 per share quarterly dividend rate declared and paid for the third quarter of 2005.
