

## Ampco Awarded Parking Management Contract for Lambert-St. Louis International Airport

NEW YORK--(BUSINESS WIRE)-- **Ampco System Parking** has been awarded a multi-year contract to manage parking operations at Missouri's Lambert-St. Louis International Airport (STL).
