

## Tampa Sports Authority Awards Contract for Three Golf Courses to ABM's OneSource Landscape & Golf Services

NEW YORK, May 05, 2010 (BUSINESS WIRE) -- By a unanimous vote of its Board of Directors, the Tampa Sports Authority (TSA) has awarded **OneSource Landscape & Golf Services, Inc.**, a contract to provide golf course maintenance services to three 18-hole golf courses in the Tampa area.
