

ABM Industries Continues Best-Ever Quarterly Dividend Rate

SAN FRANCISCO – June 6, 2006 – The Board of Directors of ABM Industries Incorporated (NYSE: ABM) has declared an alltime-high third quarter cash dividend of \$0.11 per common share payable on August 7, 2006 to stockholders of record on July 7, 2006. This will be ABM's 161st consecutive quarterly cash dividend, and is \$0.005 (4.8%) above the \$0.105 per share quarterly dividend rate declared and paid for the third quarter of 2005.
